## FEE SCHEDULE SCHOOL YEAR 2018 - 2019

**Application fee** \_\_\_\_\_ € 1,500  
The fee is payable upon formal acceptance of a place at the school. It confirms and secures your child's place in the school and is non-refundable.

**Development fee** \_\_\_\_\_ € 4,500  
This is a one-time, non-refundable fee, payable for all students **from Pre-school onwards**. The fee is devoted to the upkeep of our buildings and grounds.

All **field trips, snacks, organic lunches & languages** are included in the fees (excl. French in nursery classes).

**Special Educational Needs (SEN)** annual SEN fees will be invoiced according to the specialist's initial estimate and may be subject to modifications.

**Bus Service** \_\_\_\_\_ € 5,029

### Methods of Payment (arrival during first term)

Payments must be made in euros, either by bank transfer to the bank account specified below or by cheque. We send one invoice for the annual fees before the start of school. These are broken down to include tuition plus any options: languages, bus, uniforms and SEN. Payments are due either on the single full payment option, or in 2 equal instalments. The first instalment is to be paid before the start of school, the balance is payable in January. By request, FIS can invoice the employer directly.

### Late Payment

Should payment be delayed for more than 2 weeks a 5% monthly interest charge will be claimed. If payments are delayed for more than 1 month the director of FIS may terminate the schooling contract at the end of the month following the director's written notice.

### Late Arrival

For arrivals from January onwards, only the single payment option is available, without the 2% discount. Invoicing will be done as follows :

- First term (September to December) 100% of the annual tuition fees incl. cost of bus service
- Second term (January to March) 60% of the annual tuition fees incl. cost of bus service
- Third term (April to June) 40% of the annual tuition fees incl. cost of bus service

### Early Departure

Notice of departure must be given in writing 30 days in advance. Pupils leaving FIS before the school year has ended will be refunded as follows:

- Departure by 31 December - 50% of the billed tuition fees incl. the bus service and SEN fees.
- Departure by 31 March - 25% of the billed tuition fees incl. the bus service and SEN fees.
- Departure after 1 April - no refund

**Discounts:** We offer a 5% discount on tuition fees for the sibling(s) in the school, provided they attend simultaneously. There is a 2% discount on tuition fees when using the single full payment option.
